ORD is pleased to announce UNC-CH has become a Tier II member of the National Institute for Innovation in Manufacturing Biopharmacueticals (NIIMBL), a \$200M NIST public-private consortia whose goal is to develop manufacturing technology solutions to industry biomanufacturing challenges. On October 4th, from 12 -1:30 PM UNC will host a workshop led by the NIIMBL Chief Technology Officer (CTO) to detail how you can apply for funding through this

NIIMBL presents funding opportunities for UNC faculty whose work in fields of chemistry, physics, materials science, biomedical engineering, pharmacy, antibody therapy, gene and cellular therapies, sensing technologies and robotics may have application to biologics manufacturing. It also presents opportunities for faculty startups and will be announcing a round of full project calls this fall.

UNC-CH works closely with NC State, a founding Tier I member who employs NIIMBL's CTO Ruben Carbonell and is active in assembling competitive project teams. The NC General Assembly has appropriated \$2M for NC researchers to use as cash cost-share to support proposals to NIIMBL. 

# NSF and NIH Changes on Protection of Human Subjects, Starting January 2018

#### NSF Changes to "Common Rule"

NSF proposes changes to guidance on human subject research. The draft PAPPG now references eight categories of research that qualify for exemption to Institutional Review Board (IRB) approval. In addition, it now includes the new award-specific condition that it is the organization's responsibility to ensure that an IRB approval for human subjects work remains valid at all times that such work is being conducted. Like the vertebrate animals' guidance, IRB approval must be obtained if the protocols have changed substantively from those originally proposed and approved. Further direction has been added regarding supplemental funding: it does not require a separate IRB approval letter unless the scope of the project has substantively changed.

#### NIH Changes to Human Subjects and Clinical Trials-

Michael S. Lauer, MD, Deputy Director for Extramural Research, NIH, advises the following regarding the policies at NIH regarding studies involving human subjects:

First, become familiar with the new PHS Human Subject and Clinical Trial Information forms package (FORMS-E). <u>Learn about the new form here</u>.

Second, see if your research meets the <u>NIH definition of a clinical trial</u>. Still unsure? Contact your NIH program official.
